

#### **Notes**

The helmet is composed by a shell made by ABS equipped with a peak made by poly carbonate, a harness composed by a cradle made by terylene (PET), by a sweatband made by sponge and by a headband made by LDPE, a chin-strap composed by a tape made by polypropylene fiber a by a buckle made by LDPE, and a head top pad made by PVC. The helmet is equipped with a wheel regulator, made by LDPE, positioned in the rear internal part of the helmet that permit size adjustment between 53 cm and 64 cm. Four colour variants provided for the shell (white, orange, blue and yellow).


