



2. Levels of protection offered by the personal protective equipment

The protection equipment PS73 - Height Endurance Mountaineer Helmet is in conformity with the basical requirements and with the following additional requirements provided by the standard(s) of reference for the particular fields of use the device is addressed to:

Notes

The helmet model "PS73 - Height Endurance Mountaineer Helmet" is made by one only size: shell size (54-63) cm. The external shell is made by ABS; protective padding is made by EPS foam (density 22 g/l), while comfort padding (sweat band and head top) is made by lycra + sponge. The chin strap webbing is made by polyurethane, while retention webbing is made by terylene; plastic headband is made by LDPE. Sizes can be adjusted, in the possible range of the shell, by a wheeled system, made by ABS, positioned on the rear part of the helmet. Weight of the complete device is 450 grams. Device is made into five different colours: white, yellow, orange, red and blue. This helmet is additionally in compliance with clauses 5.1.1 (Shock absorption), 5.1.2 (Resistance to penetration) and 5.2.1 (Very low temperature, -30 °C) of the standard EN 397:2012 + A1:2012 "Industrial safety helmets".




